- Nominated by a WVSCPA member in good standing, other than the nominee.
- Posthumous nominations will be accepted, but no later than one calendar year after their date of death.
- Nominations must be submitted no later than December 15 of the current year.

# **Outstanding CPA in Business & Industry Award**

The Outstanding CPA in Business and Industry Award has two major purposes. The first is to recognize the achievements of individual CPAs employed in business and industry. The second is to promote the CPA designation as the premier professional credential for financial managers in business and industry.

### Eligibility

To be eligible for the Outstanding CPA in Business and Industry Award, the nominee must be:

- Member in good standing of the WVSCPA.
- Actively employed in or retired from business and industry.
- Nominee must have at one time held a CPA license but does not currently have to hold an active license.
- Distinguished by having made a significant contribution to the growth and success of his/her employer organization or a notable entrepreneurial achievement.
- Distinguished by having made a significant contribution to the growth and enhancement of the profession.

Nominations are due by December 15 annually.

# **Distinguished Service Award**

The Distinguished Service Award is the highest honor that the WVSCPA can bestow upon a member. The award is to grant recognition to the individual that has provided invaluable services to the Society and has made significant contributions to the profession over the years.

Due to the prestige and the high esteem in which it is held, the Distinguished Service Award will be given no more frequently than every three years.

### Criteria to be considered in nominating an individual for this award are as follows:

- 1. A minimum of twenty (20) years actively engaged in the accounting profession.
- 2. A member of the WVSCPA for a minimum of ten (10) years.
- 3. Shall have been an outstanding and recognized leader in the WVSCPA and a local chapter of the WVSCPA. As a minimum the individual should have served as an officer and director of a local chapter and as a committee chairperson, officer, and director of the WVSCPA.
- 4. Shall have demonstrated the above type of outstanding leadership on a consistent basis for a number of years.
- 5. Shall have been an outstanding and recognized leader in the accounting profession.
- 6. Shall have been a recognized spokesman for the accounting profession in West Virginia through public appearances, speeches, articles, etc.

For an individual to be considered for this award, the person must be nominated and seconded by either a member of the Board of Directors of the WVSCPA or a past president of the WVSCPA. The nomination must be submitted by an appropriate nominator no later than the January Board of Directors meeting. When considering the nomination of an individual for this award, it should be remembered that this is a very high honor and should only go to a truly outstanding individual.

The selection of an individual for this award will be done by secret vote of the Board of Directors and a nominee must receive affirmative votes from a majority of the directors.

## **Outstanding CPA in Government Award**

### CRITERIA

To be eligible for the Outstanding CPA in Government Award, the nominee must be:

- Member in good standing of the WVSCPA
- Employed in local, state, or federal government.
- Nominee must have at one time held a CPA license but does not currently have to hold an active license.
- Government employees who have retired less than one year prior to the application deadline, as well as elected and appointed officials are also eligible.
- Having made a sustained and significant contribution to the increased efficiency and effectiveness of his/her government organization. *This is the most important criterion.*
- Having made a significant contribution to state and national professional organizations, and in the level of government for which nominated.
- Having made a significant contribution to the growth and enhancement of the profession.

Nominations are due by December 15 annually.

# **Outstanding Accounting Educator Award**

This program is designed to recognize full-time college accounting educators distinguished for excellence in classroom teaching and for active involvement in the accounting profession.

To be eligible for the outstanding educator award, the nominee must meet the following guidelines:

- You do not have to be a CPA, a member of the WVSCPA, nor hold a doctoral degree.
- Be a past (retired within 3 years) or current full-time accounting educator at a West Virginia post-secondary educational institution.
- Be distinguished for excellence in classroom teaching and motivating students.
- Having contributed to the accounting profession, as demonstrated by active involvement in professional activities such as participation in professional accounting organizations.
- Noted for their teaching abilities but are now primarily involved in administration or research are eligible for the award.

Nominations are due by December 15 annually.

# **Public Service Award**

To be eligible for the Public Service Award, the nominee must be a CPA and be a member in good standing of the WVSCPA. The nominee will be examined according to the following criteria:

- Member in good standing of the WVSCPA.
- **Demonstrates Leadership** The positions held by the candidate will be considered and any substantial accomplishments during those terms. The candidate will be assessed on whether he/she has shown initiative by founding an organization, developing programs, or directing a major turnaround of a charitable group.
- Impact on the Community The impact the candidate has made in a community, including the number of people who benefited from the candidate's activities, and the importance of those activities on the community's overall well-being will be evaluated.
- **Involvement in the Community** The candidate's current level of involvement, as well as the length of time the candidate has been involved in charitable and/or civic activities will be assessed.
- **Outstanding / Unique Service** It will be determined whether the candidate has done something truly different or outstanding or if the program the candidate is involved in or the contribution by the candidate is unique in any way.

Nominations are due by December 15 annually.

# Kathy Eddy WV Young CPA of the Year Award

This award will be bestowed on a CPA who is a member of the WVSCPA and a local chapter. The individual, age 35 years or younger as of the end of the current fiscal year, shall have made significant contributions to the accounting profession and the community and is a member of at least one other professional organization. Some of the criteria to be considered in selecting a candidate for this award include:

#### Professional achievement suggested:

- If in public practice, became a supervisor, manager, or partner.
- If not in public practice, management level in industry or government, active faculty member, administrative management position, or started a successful business.
- Written an article which has been published and is significant to the profession or the public.
- Significant speaking engagements.
- Participates in a mentoring program, either inside or outside the firm or company.

#### Significant accomplishments within the WVSCPA or a local chapter:

- Committee chair or officer.
- Outstanding committee member.
- Chair or outstanding participant of a major WVSCPA or local chapter function or seminar.
- Community contributions and significant achievements:
  - Chamber of commerce.
  - Civic clubs, Charitable organizations.

#### Membership in at least one other professional organization, such as:

- AICPA
- Institute of Certified Management Accountants.
- American Accounting Association.

### Criteria for eligibility to be awarded the WV Young CPA of the Year Award:

- Member in good standing of the WVSCPA.
- Candidate must be 35 years of age or younger May 31 on the year of nomination; and
- Meets all eligibility requirements to practice as an active CPA in the state of WV.
- Member of a local chapter and at least one other professional organization.
- Significant accomplishments within the WVSCPA or within a local chapter.
- Professional achievement suggested.
- Community contributions and significant achievements.
- Demonstration of dedication to the profession through participation in professional activities.

Nominations are due by December 15 annually.

# Witschey Award – Outstanding Chapter

Each year the Society presents the Witschey Award to one of the Society's local Chapters. The Award is named for the late Robert E. Witschey, who served as Chairman of the AICPA during the years of 1962 and 1963. The Witschey Award has been given by the Society to a deserving Chapter every year since 1974.

Requirements to be considered for the award:

- Chapter leadership MUST designate a representative to serve as a member of the Awards Committee.
- Chapter leadership will be required to submit a nomination for each WVSCPA award category. If the Chapter does not have a current member who meets the award category nomination requirement, they must provide the Awards Committee with written documentation stating this for the award category.

Judging Criteria:

- Total number of meetings held and attendance at each meeting.
- The most successful meeting held.
- How the profession was promoted to local high schools and colleges
- How the Chapter promoted social interaction among members by holding a meeting during which Chapter members were able to interact in a casual setting.

  - 3. Contribution to the profession
  - 4. Creation and implementation of unique initiatives(s)
  - 5. Involvement with alma mater or other local colleges and universities

Please provide supporting documentation as evidence of accomplishments. This may include letters of recommendation from supervisors, peers, students, community organizations, etc. Resumes are not required but are strongly recommended. Winners will be selected by the Women to Watch Awards Selections Committee and recognized during the Committee Day luncheon in May.
