- Taxation:** Provide current federal and state tax information to members. Promote cooperation between the Society and the IRS, and the WV Department of Tax & Revenue. Be a liaison with state, local, and federal regulators. Communicate tax legislation issues to the membership.
- Young CPAs:** Determine the needs/interests of the younger segment of the Society and design programs and events to accomplish this.
